

COMMENTS FROM THE CHAIR



In the past year two separate research projects have looked at the history of INF.

The first project asked people in Myagdi District what had helped bring about change in the community over the past 20-30 years. The community members mentioned INF as a significant influence in bringing about positive change. The second research project was exploring the change process within INF that resulted in the creation of INF Nepal. Both projects show different aspects of INF's work. The first is in helping communities bring about positive change in their lives; helping people experience life to the full. The other is in ordered change within the INF organisation to enable and support the most effective work in health and livelihoods.

The past year has seen some significant changes within INF International as we seek to support the work of INF Nepal.

A change in the structure of the Board has enabled INF International to fulfil its governance and support functions and help the INF family "own" the work of INF International in more practical ways

Chris Drew, along with his family, left INF in July 2019 after ably serving for five years as Nepal Country Director of INF International. Chris led the Kathmandu team with care, capably supported the expatriate team and was a valued support to the INF Nepal leadership and Board. Chris also managed a difficult and painful reduction in staff in the Nepal Country Office to provide for a more financially sustainable organisation that could maximise the funding that was directed towards supporting the expatriate team and the work of INF Nepal.

The Board is also pleased that it has found another "right" person in Phil Morris who arrived in Nepal in July to start as Nepal Country Director. We welcome his skills and wisdom, his experience as former INF Australia CEO, and

his commitment to, and vision for the work of INF. The impact of INF/I's partnership with INF/N remains huge and this report describes some of what has been achieved in the last year.

However, it has been a difficult year for the team at INF/I's Nepal Country Office in Kathmandu. Liaison Manager, Jay Budhathoki passed away just after the year-end following a shock diagnosis for cancer in May and we continue to grieve his loss and pray for his wife and son. Jay's illness coincided with a change in Nepal government policy which blocked the processing of visas for INF volunteers for some time, which had a significant impact on the work of INF/I and INF/N.

INF International is grateful for all those who provide support to the work of INF: expatriate volunteers and their supporters, Nepali staff, donors, and those who remember and pray for INF around the world. Thank you for the way that you have each contributed to INF in the past year.

Our work:

Key achievements from the past year from our partner, INF Nepal.



Eight-year-old Resmi Buda lives in Patrashi and has cerebral palsy. When an INF Community Mobiliser found her, she was alone in her house and unable to walk. Her parents were unsure how to care for her and she had become too heavy to be carried.

The Community Mobiliser brought a physiotherapist to see Resmi. Initially, Resmi was silent and non-responsive but over time she began to trust the physiotherapist and followed her instructions. The physiotherapist worked together with Resmi's mother, teaching her basic exercises to strengthen Resmi's legs and upper body. She also recommended Resmi socialise with other children to make friends and suggested the family build parallel bars so Resmi could practice standing up.

At the next follow up visit it was clear Resmi's mother had been helping her daughter do her exercises. The family had also built the parallel bars and Resmi had started learning how to walk with them. The INF Nepal's CBR worker recommended an accessible toilet be built for Resmi.

There are now plans for Resmi to have surgery that will further loosen her leg muscles. Her mother is incredibly positive about Resmi's future and thankful for INF's support in transforming her daughter's life.
































BAL KRISHNA'S STORY

Bal Krishna [19] is a student from Banke district. Three years ago, he noticed small patches on his left knee. When he went to the local hospital, he was diagnosed with leprosy and began multi-drug therapy.

Despite regularly taking his medication, Bal Krishna's fingers began to claw on one hand. He was extremely worried that this visible sign of leprosy would mean his peers would discriminate against him.

This year, in conjunction with the Nepal Government's Department of Health, Green Pastures Hospital held a reconstructive surgery camp for people affected by leprosy. Reconstructive surgery services are extremely limited in western Nepal, but have life-changing potential for patients with stigmatising conditions.

Bal Krishna attended the camp and had his hand corrected. He went on to stay at the hospital for over three weeks, where he received health education, counselling, healthy food and follow-up care. With this kind of holistic support, he left the hospital with a new level of confidence and strong sense of dignity.

Pokhara Study Centre [PSC]

INF International runs a small study centre in Pokhara to support INF volunteers in the education of their children.

The 2018/19 school year settled into a productive and stable year with staffing but ended sadly with Libby Hayes alone as the only teacher with a valid visa for the final month. We added two new Teacher Assistants, a part time cleaner and a new Admin Assistant to our staff. In Term 4, we opened the school to non-INF children and our population grew. In term 1 of 2019 there are a total of 34 students, up from 12 students in term 1 of 2018.

The greatest encouragement for the year was the opening of our new class 2 classroom which has proved a wonderful asset. Students at PSC are having wonderful opportunities to learn through an excellent academic programme and after-school clubs offered over the year: Circus, Rangers, Athletics, Green Fingers and Drama.


